Cancelled registrations occurring in fewer than 48 hours before first class date will be charged a late cancellation fee of no less than \$15. Pro-rated classes are only available by permission of John Raker at time of registration and will be charged the written per class charge listed in the SCC Registration Book. The Tennis Staff may cancel a class due to weather and then schedule a make-up class. Classes held for more than 50% of class time will not be made-up. "No Shows" by players are not subject to make-up classes or refunds.

I hereby consent to emergency medical or hospital service that may be rendered by accredited/ certified medical personnel or at accredited hospitals by appointed physicians in the event such need arises for my child. Registration in any 2010 SCC Tennis Clinics, Events or Programs is without assumption of responsibility of any kind by Spotswood Country Club, SCC / VPT Staff and / or Virginia Professional Tennis.
